QUESTION #1: What is the percentage of Canadian-born, immigrants and non-permanent residents of 15 years and over receiving employment insurance in 2000, for the province of Ontario?

ANSWER:

• Immigrants and non-permanent residents are less likely to receive EI than Canadian-borns in 2000. 6.2% of Canadian-borns received EI in 2000, compared to 5.7% of immigrants and 5.2% of non-permanent residents.

QUESTION #2: What is the percentage of immigrants who are 15 years and over receiving employment insurance in 2000, by period of immigration, for the province of Ontario?

^{*} Use with caution. Not all immigrants arriving between 1996 and 2001 would have been eligible for EI in 2000.

• When looking at immigrants receiving EI, the percentage of immigrants receiving EI tends to decrease for immigrants who have been longer in Canada. Seven percent (7.4%) of immigrants who have arrived between 1991 and 2001 received EI in 2000, three times the percentage of immigrants who arrived before 1961 (2.6%).

QUESTION #3: What is the average amount received in employment insurance by beneficiaries of 15 years and over in 2000, for the province of Ontario?

ANSWER:

	Mean (\$)	N
Canadian-born	4,395.59	379,630
Immigrants	4,477.89	164,098
Non-permanent residents	4,889.39	3,963
Total	4,423.82	547,691

- Although a lower percentage of immigrants receive EI compared to Canadian-born, immigrants receive a higher amount of EI benefits (an average of \$4,477.89 for each immigrant beneficiary, compared to \$4,395.59 per Canadian-born beneficiary).
- The same applies to non-permanent residents (\$4,889.39 vs. \$4,395.59 for Canadian-born beneficiaries).

QUESTION #4: What is the average amount received in employment insurance by immigrant beneficiaries of 15 years and over in 2000, by period of immigration, for the province of Ontario?

- When looking at the total amount of EI benefits received by immigrants in 2000, immigrants who had arrived more recently received higher EI benefits than those who had arrived between 1971 and 1980.
- The average amount received by immigrants who have immigrated before 1971 increases. While immigrant EI beneficiaries who immigrated between 1971 and 1981 receive on average \$4,257.04 per beneficiary, immigrants who arrived before 1961 receive on average \$4,748.45 per beneficiary.

Note:

Numbers may not add up to the total due to rounding.

Refers to total Employment Insurance benefits received during calendar year 2000, before income tax deductions. It includes benefits for unemployment, sickness, maternity, paternity, adoption, work sharing, retraining and benefits to self-employed fishers received under the federal Employment Insurance Program.

Reported for: Population 15 years of age and over, excluding institutional residents

DEFINITIONS:

Immigrant: or landed immigrant, is a person who has been granted the right to live in Canada permanently by immigration authorities.

Non-permanent resident: a person from another country who had an employment authorization, a student authorization, or a Minister's permit, or who was a refugee claimant at the time of the census, and family members living here with him or her.
