

QUESTION: Where are immigrant financial auditors and accountants coming from and where do they settle in Ontario?

ANSWER:


Between 1995 and 2005, 20,142 immigrants landing in Canada were planning to work as financial auditors and accountants, and 13,143 of them were planning to settle in Ontario.

Immigrants planning to work as financial auditors or accountants were predominantly men (62%).




Sixty percent of immigrants planning to work as financial auditors or accountants had a bachelor's degree. Another fifth (19%) had a master's degree.





Immigrants planning to work as financial auditors or accountants are more likely to immigrate under the skilled worker class. Among immigrants arriving as skilled workers, 77% were principal applicants, and 13% were dependents.

A fifth (21.6%) of immigrants planning to work as financial auditors and accountants and settle in Ontario were born in India. Pakistan comes second with 9% of immigrants, followed by the Philippines with 9%.

Four of the most important countries of birth for immigrants planning to work as financial auditors and accountants were in South Asia (India, Pakistan, Bangladesh and Sri Lanka).

In Ontario, more than half (54%) of immigrants planning to work as financial auditors and accountants were planning to settle in Toronto. The second most popular city of destination was Mississauga (10%), followed by Scarborough (7%).

Except for Ottawa and Windsor, all of the main cities were immigrants planning to work as financial auditors or accountants were in the Greater Toronto Area.

Notes:

The data is for 1995-2005. Immigrants were asked on arrival to Canada what was their intended occupation and their city of destination. Data do not take into account subsequent moves to or from Toronto as well as occupational changes.

DEFINITIONS:

Immigrants are permanent residents, formerly called landed immigrants.
