Creatively redefine the boundaries of environmental research

Since the PhD program was established in 1991, ES PhD program students have worked at the cutting edge of critical, interdisciplinary Environmental Studies research. Benefitting from our rich research culture and dynamic, supportive community, ES PhD students undertake a four-to-six year degree tailored to their individual research, career, and personal goals. As a direct result of their individual research programs, our PhD alumni have found prestigious positions in academia, government, and the nonprofit and community sector, both nationally and internationally.

The PhD Program in Environmental Studies is organized in four stages: Program Plan, Comprehensive Examinations, Dissertation Proposal and Dissertation. Students are required to take two courses: ENVS 8102 PhD Research Seminar (in term 1) and ENVS 8103 PhD Research Design Workshop (in term 5). Students are supported to develop their otherwise flexible, individual programs by a dedicated supervisory committee, representing and facilitating their interdisciplinary research interests.

- Environmental and social justice
- Environmental humanities
- Arts-based research and community arts practice
- Global political ecology and critical development studies


The Master in Environmental Studies program prepares students to be agents of environmental and urban change through research, teaching, activism, artistic and professional practice.

Joint program with Osgoode Hall Law School

Study in the only joint law and environmental studies program in Canada, offering you the opportunity to gain both a Master in Environmental Studies degree and a Juris Doctor. Through cutting-edge interdisciplinary teaching and research in law and the environment, you will explore how these two critical fields intersect.

This unique program brings together one of Canada's premier law schools with one of its most innovative environmental studies programs. It draws upon Osgoode's recognized strength in social justice, environmental, planning and aboriginal law, and Faculty of Environmental & Urban Change's acclaimed leadership in interdisciplinary environmental studies.

The program attracts a small group of some of the best students interested in environment and law nationwide. Graduates of the program have gone on to a variety of positions in government, private law firms, non-profit organizations, business, the academy and other settings.

The MES/JD Joint Program offers students the opportunity to complete both the MES and JD degrees in just under four years, approximately one year less time than it would take to complete the two degrees separately.



He is a migration scholar and urban geographer whose research explores the complex relationships between people and place and especially in the ways that flows of capital, labour, bodies, and ideas transform various landscapes.

Environmental Studies PhD Vanier Scholars

Vanier Canada Graduate Scholarship (VCGS) recipients represent the very best doctoral researchers in Canada. In addition to demonstrating the highest level of excellence in their scholarly and research pursuits, Vanier scholars are community and professional leaders in their fields whose work has a real impact in the world. The ES PhD program has supported nine, brilliant Vanier scholars since the VCGS program began in 2008.





Isaac Asume Osuoka, PhD

Asume is an international development scholar with almost three decades of engagement with communities, civil society and governments in Africa and globally. His doctoral dissertation, titled "Privatizing Dissent: Community, Civil Society, and Contested Hegemonies in Southern Nigeria" (2013), exposes the theoretical anomalies and practical implications of applying euro-western concepts of civil society to non-western sites.



Tania Hernández-Cervantes, PhD

Tania Hernández-Cervantes' doctoral dissertation (2017) is titled "Reconnecting the City and the Countryside with Food and Agriculture in the Era of Globalization and Neoliberalism: Nopal, Mexico City, and Milpa Alta." It examines food linkages between Mexico City and a nearby agricultural region, Milpa Alta, through a commodity supply chain analysis of nopal, a native food, from the 1990s to the present.



Oded Haas, PhD

Oded's dissertation (2021), titled "Housing Policy, Design, and Struggle: The Colonial Production of Space of Israel/Palestine, One New City at a Time," examines how a housing crisis framework, including local struggles for the right to housing, has been utilised by the Israeli Zionist regime to counter insurgent practices of Palestinians in the country and simultaneously appropriated for the Palestinian national struggle.



Syrus Marcus Ware, PhD

Syrus has been making art and engaging in activism for 26 years. His doctoral dissertation (2021), titled "Irresistible Revolution: Black, Trans, and Disabled World-making through Activist Portraiture," is part of an extensive body of work that asks: what can Black, trans, and disabled activism teach us about disability arts? He is now an Assistant Professor in the School of Arts at McMaster University.



Susan Bell Chiblow, PhD

Sue is an Assistant Professor at the University of Guelph. Crane Clan born and raised in Garden River First Nation, she has worked extensively with First Nation communities for the last 30 years in environmental related fields. Her dissertation (2022) is titled "Understanding Anishinaabek G'giikendaaswinmin (knowledge) on N'bi (water), Naaknigewin (law) and Nokomis Giizis (Grandmother Moon) in the Great Lakes Territory for Water Governance."



Balikisu Osman, PhD

Balikisu's doctoral dissertation (2023) is titled "Security in Uncertainty: Analysis of Climate Risks and Household Response to Food Insecurity in Northern Ghana" and explores, using a participatory approach, smallholder farmers' experience with climate risks related to food security in the region. She recently joined the World Bank Group as a Young Professional, combining leadership development and direct work on the frontlines of global development operations.



Nadha Hassen, PhD

Nadha is a public health and environmental studies scholar focused on healthy and just spaces and places. Her doctoral dissertation (2023), titled "Park Perceptions and Racialized Realities: Visualizing and Centering the Experiences of Racialized People in Toronto's Public Greenspace," examines the experiences of racialized people in public urban greenspaces in Toronto and links to mental health and wellbeing by exploring concepts like equity, access, safety and belonging.



Maureen Owino, PhD Student

Maureen's PhD research is titled "When HIV and COVID-19 Pandemics Collide in Black Communities in Canada" and confronts issues relating to pandemic responses that impact already vulnerable communities. Her work involves the burdens borne by Black women living with sexually transmitted and blood-borne infections in the context of the additional impacts of COVID-19 and HIV, exacerbated by systemic factors such as racism, sexism, homophobia, and poverty



Cole Swanson, PhD Student

Cole Swanson is a multispecies artist and educator based in Toronto. His PhD research takes up an interdisciplinary, artistic examination of the multispecies life-worlds within Toronto's large, double-crested cormorant colony. Working against dangerous imaginaries of cormorants fueled by religious, settler-colonial, and extractivist histories and politics, his dissertation research intimately examines life in the colony to illuminate the entanglements between avian, human, and more-than-human worlds.

Financial Support

Funding in the MES program

Full-time MES students are offered a fellowship. The fellowship is disbursed equally over the 6 full time terms. Funds cover tuition fees, leaving the balance for living/studying expenses.

Funding in the PhD Program

PhD students are offered a guaranteed annual funding package for the first 4 years of their program. This package normally includes a fellowship and a teaching assistantship. As a member of CUPE 3903, students become eligible for additional funding in Year 5 and 6 (if applicable). Fellowship covers tuition fees. Teaching Assistant wages include benefits.

Additional Funding

The program also offers many entrance scholarships. Students are also invited to apply to the numerous internal scholarships offered in the Faculty of Environmental & Urban Change, the Faculty of Graduate Studies, as well as York University. We also support students in the development of their applications to external (Tri-Council/OGS) scholarships. Fieldwork scholarships are also available.


Admission Requirements

MES Program (MES-Planning, MES/JD)

- Honours (four-year) undergraduate degree from an accredited institution B+ GPA over the past two years (or full-time equivalent) of academic study.
- Significant work or volunteer experience, or participation in other relevant activities that are determined to be equivalent to an Honours undergraduate degree.
- For MES/JD, apply and be accepted into both programs separately. You may apply to both programs simultaneously or during your first year in either program.

PhD Program

- Master's degree from an accredited institution
- B+ GPA or equivalent



How to Apply

- 1. Complete the York University online Graduate Application Form
- 2. Pay the application fee
- 3. Submit supporting documentation* through YorkU's Online Portal: MyFile

*Supporting documentation includes:

- Transcripts
- · Research Statement
- · Resumé or Curriculum Vitae
- Supplementary Forms
- English language proficiency test

Prospective students must pay the application fee in order for their application to be processed. Once you pay, you will get an email with your MNYFile Details. Myfile allows you to upload and track your application, and follow the checklist. Please be reminded that we only review complete files and only accept official documents.
