# Awards for Students with Disabilities 2023-2024

In accordance with guidelines established by the Ontario Human Rights Code (Section 14), York University has established a special program for students with disabilities to offer financial assistance in the form of scholarships, awards, and bursaries to assist students with disabilities to meet their financial needs during the academic year.

- **Step 1:** Complete the online Student Financial Profile and select all programs for which you wish to be considered. Hard copies of the SFP are available at Student Accessibility Services (if needed).
- Step 2: Complete this application form and select all awards for which you wish to be considered.

  Only one application form is required.
- Step 3: Submit supporting documentation (letter from your counselor, medical certificate and/or a learning-disability assessment completed by a qualified practitioner) if you are applying for awards that have specific criteria.

- Preference given to students pursuing a major in Jewish Studies or in the Jewish Teacher Education program.

- Full time student with a psychiatric disability entering or enrolled in the Master of Social Work program at Liberal Arts and Professional Studies
- Demonstrates financial need.
- If there are no candidates enrolled in the Master of Social Work program who have a psychiatric disability, the award will be given to a full-time student with a psychiatric disability entering or enrolled in the Bachelor of Social Work program.
