

SPECIALIZED HONOURS THESIS - PSYC 4001 6.0

Faculty of Health – York University Guidelines and Application

In order to register in Psychology 4001 – Specialized Honours Thesis, the student must have been accepted into the Specialized Honours Program in the Department of Psychology and must have completed the following pre-requisites:

HH/PSYC 1010 6.00 (Introduction to Psychology), with a minimum grade of C.

HH/PSYC 2010 3.00 (Writing in Psychology)

HH/PSYC 2020 6.00 (Statistical Methods I and II) or substitutes.

HH/PSYC 2030 3.00 (Introduction to Research Methods) or substitutes.

HH/PSYC 3000 3.00 (Professionalism and Communication in Psychology)

HH/PSYC 3010 3.00 (Intermediate Research Methods)

HH/PSYC 3031 3.00 (Intermediate Statistics Laboratory)

Students may then complete and sign this application with their supervisor, and either (a) upload the completed application to the Mach form: <https://tinyurl.com/y36zc3o7h>, which will be received by the undergraduate office, or (b) drop the form off to the undergraduate office at BSB 291. Once submitted to the undergraduate office, students will be contacted by email if their enrollment in 4001 is not approved. Approved students will be able to enroll in Psychology 4001 online approximately 1 week after submitting this application. If you have any concerns, or are not able to register, please contact the Psychology Department Undergraduate Office (psyc@yorku.ca; (416) 736-5117).

An expanded description of the thesis project, as well as a representative bibliography, should accompany the Specialized Honours Thesis Application forms. **The description should be at least 150 words.** It should be as concrete as possible and should clearly indicate the goals of the research and both the obligations of the student and the obligations of the professor. This description will serve as a combination of course description and teacher-student contract. Often the student can write out the project description after a discussion with the professor, but the professor should not sign the contract until the description has been read and revised as necessary.

1. The description should be concrete and explicit.
2. Do not leave agreements “understood” – they often become “misunderstood”.
3. If there are to be discussion meetings, set up regular times.
4. The representative bibliography should include at least 5 to 10 relevant readings and can be generated by the professor, the student, or a combination of both.

Program Learning Outcomes

Upon completion of this course, students should be able to:

1. Use data analytic software for analysis of psychological data.
2. Design, execute, analyze and interpret results from a study examining a specific research question.
3. Express in written form psychological findings using APA style.
4. Express in written form, a research study in psychology.
5. Recognize limits of conclusions based on inferential statistics.
6. Critically identify limitations of individual research endeavors.
7. Apply ethical principles of the CPA code of ethics to their own research.

Tentative Grading and Timeline (this is subject to change):

Thesis Proposal	10%	Due to the supervisor by January 15 th
Poster Day	5%	Early April
External Thesis Evaluation	20%	Mid-April (feedback within 1 week)
Supervisor Thesis Evaluation	50%	Late-April
Seminar Participation	15%	Details to be provided in the course syllabus

A *Thesis Proposal* which includes the Introduction (literature review) and Method (proposed methodology) sections must be submitted by the last day of the December examination period and when this is not possible, no later than January 15th. This work is graded by the thesis supervisor and is worth 10% of the final course grade. This deadline will ensure that the student begins writing in the first term and that progress will be made in the development of the methodology. It also gives the student the opportunity to receive feedback from the supervisor. It is highly recommended that some or all of the thesis data be collected by the end of the Fall Term.

Poster Day participation is mandatory. This is graded as pass (5/5) or fail (0/5). Poster Day is held in early April, typically just prior to the examination period. The poster presentation will provide an opportunity to receive feedback about the thesis before submitting the thesis draft.

The *External Thesis Evaluation* will be provided by another faculty member who evaluates the final product (the written thesis) and not the process (e.g., the amount of work that was involved in getting to the final product). The Thesis Coordinator(s) will be responsible for assigning a second reader to each thesis. In order to give the second reader enough time to evaluate the work and provide his/her grade to the supervisor, each student will be required to submit a draft of the thesis by mid-April. This typically accounts for 20% of the student's final grade.

The *Supervisor Thesis Evaluation* accounts for 50% of the final grade and reflects an evaluation primarily of the final product, with consideration also being given to the student's contributions to the process (ideas, creating stimuli, recruiting and running participants, etc.).

Seminar Participation is a required component of the Specialized Honours Thesis course. As such, the instructor will contribute 15% towards the student's final grade. Although this seminar will not take place every week, each student should ensure that they are free during the scheduled class time. More details on this participation component will be available in the course syllabus that is provided during the first class session.
