Course Description

This course covers problems, experimental methods and research findings in sensation and perception. Vision and hearing are covered in detail, including discussion of the structure and function of the eye and ear, and cortical areas responsible for processing visual and auditory information.

Upon completion of this course, students should be able to:

1. Demonstrate broad knowledge of biological determinants of sensation and perception .
2. Describe and evaluate current theory and research in sensation and perception.
3. Understand and interpret principles of sensation and perception in everyday life.
4. Define causes of human sensation and perception from different perspectives.

Required Text

Wolfe et al. (2020). *Sensation and perception, sixth edition*. Sinauer Associates.

There are other books with the same title by different authors, and there are previous editions of this book. Be sure to purchase the book by Wolfe, and to purchase the sixth edition. This book is available at the York University Bookstore.

The final exam will be scheduled during the official exam period in April. We will announce the date when it becomes available.

Description of Assignments

Term tests and exam. The tests and exam will cover the lectures and the assigned readings. The first midterm test will cover weeks 1-4, the second midterm test will cover weeks 6-9, and the final exam will cover the entire course.

Weekly quizzes. To encourage you to do the assigned readings before each lecture, there will be a short online quiz at the beginning of each class, starting in week two, except in weeks where we have a test. Each quiz will cover the textbook readings assigned for the corresponding lecture.

Attendance at the lectures is highly encouraged, as it will provide an opportunity to ask questions and hear others' questions and comments.

Grading as per Senate Policy
