Course Description

The course provides an overview of the etiology, symptomatology, and classification of major clinical disorders. The course content will examine neurotic, psychotic, and personality disorders, as well as developmental and neurological problems. The main objective of the course is to gain a deeper understanding of the nature, causes of, and current treatments for psychological impairment, and more importantly an appreciation for the tentative and incomplete nature of our understanding of mental challenges.

- 1. Demonstrate in-depth knowledge of psychological health and impairment.
- 2. Articulate trends in psychological health and impairment.
- 3. Express knowledge of psychological health and impairment in written form.

- 5. Demonstrate ability to relate information in psychological health and impairment to one's own and others' life experiences.

At this time, due to COVID-19 an Attending Physician's Statement (APS) is not required, however, a reason for missing an evaluated component in the course must be provided.

Tests or examinations missed on the grounds of non-medical circumstances must be supported by appropriate documentation (i.e., death certificates, obituary notice, automobile accident reports, airline/train/bus ticket/receipts with date of booking on ticket, etc.). Airline/train/bus ticket/receipts for emergency travel must indicate destination, departure and return dates.

In the case of a make-up test/exam, the student must be prepared to write within the week following the missed test (a date will be set by the instructor). Although the content to be examined will be the same, the format may or may not follow that of the original test/examination. It is the student's responsibility to check with the instructor, TA, and/or course website as to the date/time of the make-up.
