### **Course Description**

The purpose of this course is to provide an overview of the fundamental aspects of human behaviour in groups of various sizes (from dyads to entire cultures). The investigation of human behaviour in group situations will be investigated from theoretical, empirical, and applied perspectives. The topics that will be explored include issues of group development, performance, and leadership. The course is designed to engage students with the material experientially through the integration of small group activities with lectures and audiovisual presentations.

- 1. Demonstrate in-depth knowledge of behaviour in groups.
- 2. Articulate trends in the psychology of behaviour in groups.
- 3. Express knowledge of behaviour in groups in written form.
- 4. Describe and explain limits to generalizability of research findings on behaviour in groups.
- 5. Demonstrate ability to relate information on behaviour in groups to own and others' life experiences.

Understand the basic assumptions of social identity theory (construction of the self through
groups).

development
Explain how power processes influence individual and group performance.
Compare and contrast trait, situational, and interactionist approaches to leadership se learning

Although the content to be examined will be the same, the format may or may not follow that of the original test/examination. A conflict in another course during the time of the make-up is not an acceptable reason for missing the make-up. If a student misses a make-up opportunity for good reasons (see points mentioned above), then either the prorating option is applied, or a second and final opportunity for a make-up will be arranged.
