Course Description

This course takes an historical perspective of developmental theories. Students are introduced to theories, issues and principles of development that encourage an integration of the key concepts and their applications, as well as research methods to enhance our knowledge . The course covers biological, physical, perceptual, cognitive, linguistic, and social-emotional development within multiple contexts. Students are encouraged to think critically about issues and empiricial findings.
