The fundamental concepts and application of descriptive statistics. An introduction to probability and inferential statistics, including hypothesis testing with the normal- and t-distributions.

- 3. Demonstrate the ability to summarize, organize, and present the essential features of data numerically and graphically.
- 4. Identify the differences between descriptive and inferential statistics (e.g., summarize sample data vs use sample data to make inferences about the population).
- 5. Identify limitations of descriptive statistics (e.g., cannot be used to test hypotheses about the population under study).
- 6. Demonstrate the ability to generate statistical hypotheses (i.e., null and alternative) that are applicable to various research situations.
- 7. Demonstrate the ability to formulate and perform hypothesis tests that are applicable to various research situations (i.e., *z* test, *t* tests, correlations).

Description of Assignments

MindTap Assignments: These are weekly assignments which will focus on course material covered in class on a given week. However, to accommodate those who may need a bit more time to complete assignments they are all due on Dec 06, 2019; this due date is non-negotiable. I strongly advise that you do not wait until the last few weeks of the semester to complete the assignments. Only the Problem Sets associated with the chapters from the text we covered in this course count toward your final grade. However, there are other activities (e.g., End-of-chapter problems, exam) available for you to practice course material.

Tests: Tests will be non-cumulative and cover the material from lectures, readings, and MindTap assignments preceding the test. The format of the tests will be a mix of multiple-choice and open-ended/short-answer questions (e.g., defining concepts or responses to analysis questions).

Final Exam: The final exam will be cumulative and covers all course material.
