5. State what the changes are (Example: increase / decrease to the number of major credits)

The proposed changes are to the admission criteria for eligible applicants to the ATCP. The proposal seeks to reduce the barriers for students to apply to the certificate program; upon careful review of the admissions from the past three years, we have found the barriers outlined below have not resulted in significant benefit to the students regarding their success in the Athletic Therapy program. Proposed changes include reducing the required referees, removing the 40 experiential hours criteria, and removing the standard first aid criteria. Please see item 6 for rationale.

6. Provide the rationale for the proposed changes that are rooted in the program learning outcomes.

It has been 3 years since the implementation of the new Athletic Therapy Program in 2019. Since then, the ATCP Faculty and Staff have had the opportunity to reflect on the admission criteria over three student intakes. The restrictions imposed by the current pandemic resulted in necessary adjustments to the admission criteria for the most recent cohort; student success has not been negatively impacted by these pandemic-necessary adjustments. The proposed changes below reflect the adjustments implemented and we would now like to change these permanently moving forward. As a result, the following changes are proposed with respective rationale:

1. Propose the removal of the 40 experiential hours prior to application to the ATCP. This has presented to be the most significant barrier, even prior to the pandemic, as students have continued to report significant difficulty in obtaining community volunteer opportunities directly related to the field. This is resulting in increased student anxiety as well as deterring students from applying. The intent of the community service hours was to have incoming students obtain some experience and familiarity with the clinical and field aspects of athletic therapy, but since the majority of applicants are unable to secure a volunteer position with a practicing athletic therapist, these goals are not being attained. Indeed, many applicants volunteer instead with physical education teachers or coaches, which does not give them insight into the work of an athletic therapist. Successful student applicants will obtain plenty of experience within the 3-year ATCP and it will not affect their ability to achieve the required program competencies, nor will it reduce the quality of students entering into the ATCP. Indeed, many other AT programs in the country have already removed this requirement.
2. Propose to reduce the referee requirement from two to one referee. The main premise to reducing from two (one academic and one community) to one referee is because students were finding it difficult to find an academic referee having only completed two

years of studies prior to their application. As such some professors, did not feel comfortable providing a reference, thus becoming a barrier for students. In fairness to students, we want to provide more flexibility for students to be able to find a referee, be it academic or not. With the removal of the requirement for community service hours, and the challenges surrounding the ability of students to connect with academic faculty in their first two years of their degree (due to large class sizes), a single referee is deemed more appropriate.

3. Propose the removal of the Standard First Aid and CPR-C certification or the HH/PKIN 0750.00 Emergency Care I entrance requirement. This criterion is no longer required prior to entry to the program as students will develop these skills as well as more advanced skills at a health care professional level through the required courses embedded within the ATCP. With the new program structure now in place, students will not be in placement alone in first year and thus will not require this criterion prior to entry as in the past. Also, our Program Faculty teaching these skills have noticed a varied discrepancy with the previously taught skills as the level/quality of First Aid courses can vary causing more learning challenges with first year students.

As the ATCP program continues to grow, eliminating these current barriers will encourage more applicants from the Kinesiology and Health Science student population, thus providing a larger applicant pool to select the top candidates from.

The Athletic Therapy faculty and staff have met and discussed the implications of the proposed changes as well as discussed with our relevant academic unit and have determined that it will not impact other academic units. The greatest impact will be to those students wishing to apply to the Athletic Therapy Program; it will have a positive impact as it will reduce the current barriers for application to the program. Such barriers have not resulted in high benefit to the students in relation to their success in the ATCP. As well, the ATC program director, Dr. Loriann Hynes, has consulted with the other accredited institutions across Canada and the proposed changes would align with the other accredited institutions thus remaining competitive and current as a program. These changes will provide more equity for students in the Kinesiology & Health Science program at York University who apply to the ATCP. They will not be required to source (and pay for) external First Aid certifications should the timing of PKIN 0750 not align with the application deadline for the ATCP, nor will they be ineligible to apply if they have been unable to secure a volunteer placement with a Certified Athletic Therapist due to the challenges outlined above in finding such experiential opportunities.
