1. Chair's remarks

Chair A. Moore welcomed members and explained how the meeting would be conducted online.

2. Business Arising from the Minutes

There was no business arising from the minutes.

3. Draft EDI Report

Chair A. Moore welcomed Dr. Sheila Cote-Meek, Vice President Equity, People and Culture and A. Gaukel, Senior Executive Office of the Division of Equity, People and Culture to Council in order to address the Draft EDI Strategy 2022 – 2027. Dr. Cote-Meek provided some background for the strategy and how the existing frameworks on campus supported its development. The strategy will serve as an umbrella that is meant to complement the work being done at various levels across the university. She also outlined the principles and EDI strategic directions that help to shape the report and how York will be enabling the plan including awards programs and an EDI activity fund.

Council members are encouraged to reflect on the material and complete the feedback surveys.

4. Dean's Remarks

Dean Murtha began her remarks by welcoming the Associate Dean, Learning, Teaching and Academic Programs, K. Page-Cutrara. She reminded Council members that the vaccine mandate is on pause as of May 1, 2022 and that the masking protocol for indoor spaces is extended until further notice. As well, small amounts of N95 masks are available for faculty members for their first day of classes and can be picked up from the bookstore. Alternatively, masks are available

across campus via vending machines. She reminded Council members to stay current with the campus guidelines.

Dean Murtha provided brief hiring update and expressed her gratitude to all the unit hiring committees. She confirmed that all units are aware of their 22-23 complement plans and they are hoping to hear back from the Provost office regarding any additional positions that may become available.

Dean Murtha acknowledged student achievements, student award recipients, successful AIF funding projects and provided kudos to those faculty members who received research funding. She notified Council that she had submitted a proposal for a new Associate Dean position to support EDI initiatives and will update Council members when she receives further information. She concluded her remarks by encouraging faculty members to attend the upcoming Spring 2022 convocation ceremonies and/or the alumni convocation activities for those students who convocated during the pandemic. She stressed how important this event is for students and how much it was missed by students and their families.

5. Report of the Executive and Planning Committee

R. Bishop provided the report. He acknowledged that Associate Dean M. Hamadeh would be addressing Council regarding the Faculty of Health EDI report under Other Business.

R. Bishop motioned, seconded by Professor A. Viens that Summer Authority be conferred. The motion carried.

R. Bishop informed Council that the Student Senator elections process was administered in accordance with the Rules & Procedures of Faculty Council and a candidate was elected. The Faculty of Health Student Senators are: Mohamed Elsayed Elghobashy & Amireza Goli.

6. Report of the Graduate Committee

Associate Dean C. Ardern motioned, seconded by Professor M. Morrow to approve the following two courses in the Graduate Program in Health:

The motion carried.

Associate Dean C. Ardern provided the following two items for informational purposes:

- The Graduate Committee reviewed the following change to the Graduate Program in Psychology in the areas of i) Social-Personality (SP), and ii) Brain, Behaviour Cognitive Sciences (BBCS). Removal of the History requirement for PhD Students in SP and BBCS, thus reducing the number of courses that students in those two areas need to take to fulfill their degree requirements.
- The Graduate Committee reviewed the following change for the Graduate Program in Health. Removal of Public Policy and Health (GS / HLTH 5485) as a pre-requisite for the Directed Studies in Health Studies course (GS / HLTH 5000), effective Fall, 2023.

7. Senator's Report

Professor A. Viens provided the Senator's report.

The President's remarks included:

- Updates on pandemic matters including the extension of the masking policy on campus for indoor spaces and the pause of the vaccine mandate.
- The revised timing on the opening of Markham campus
- Reflections on the Auditor General Report on Laurentian University's request to seek creditor protection
- Honorary Degree recipients for Spring Convocation

Senate held a facilitated discussion to review the following question: "What are the key parameters to consider in deciding on the timing to declare the COVID-19 pandemic disruption has ended?"

ASCP report items included minor changes that were approved to the practicum requirements for the BScN in Nursing program and admission requirements for the Certificate in Athletic Therapy in the School of Kinesiology and Health Science.

The APPRC reported on its reflections from the spring planning forum; receipt of notifications about the delayed opening of Markham Campus; the establishment of a CIBC Chair in Sustainable Finance within the Schulich School of Business.

The Awards Committee acknowledged the 2022 President's Research Awards.

9. Other Business

Chair A. Moore informed Council that notification from the Senate Academic Standards, Curriculum and Pedagogy Committee (ASCP) regarding the deferral of the implementation of the new grading schemes was received. The original implementation date for the new policy was targeted for Fall 2023 but the recommended deferral is at least one-year. Faculties are still encouraged to continue with implementation activities pertaining to the new grading scheme and ASCP requests that faculties include grading scales for both the 9.0 scale and 4.0 scale in all curriculum proposals submitted to ASCP moving forward.

Chair A. Moore welcome Associate Dean M. Hamadeh to address Council regarding the Faculty of Health EDI report. Associate Dean M. Hamadeh thanked Council for the opportunity to speak and explained that on behalf of the Executive & Planning Committee he would like to solicit feedback on how to proceed with the EDI report. He provided a link to the report in the Council chat. He encouraged Council members to review the report and stated that a survey would be circulated over the summer which would allow Council members to provide feedback once they had a chance to review the report. He thanked the working group again for their report and reiterated how purposeful, thoughtful and comprehensive the report was.

Report of the Petitions Committee of the Faculty of Health Council September 2022

ITEM FOR INFORMATION:

Year End Report 2021-2022

Committee members review material via Moodle and note individual decisions prior to weekly meetings, where final decisions are confirmed. Since March 2020, all Committee meetings have been facilitated using Zoom Conferencing to accommodate the remote working conditions.

Beginning in 2020, the Petitions Faculty Council Report is presented at the September council meeting and analyzes trends and statistics for the entire term from July 1 to June 30. Prior to 2021, the Petitions Faculty Council Reports were presented at the May council meetings and reviewed the trends and statistics from July 1 to April. The 2022 report will continue to review the trends and statistics for the entire 2021-22 term from July 1, 2021, to June 30, 2022, while comparing it to trends within the same timeframe during the 2020-21 term. However, for a long-term view on petitions, the report will also present a summary chart of number comparisons during the July – April period spanning from 2015 - 2022.

In 2021-22, a total of 843 requests were adjudicated in the timeframe of July 1, 2021 – June 30, 2022. By comparison, in 2020-21, a total of 1092 requests were adjudicated in the same timeframe. This represents an 22.81% overall decrease in petitions from last year. Similarly, petitions saw a 20.51% decrease in late withdrawal petitions from last year. Late withdrawal petitions are the most common petitions and the trends for this petition request directly align with the overall trend of decreasing petition submissions.

Likewise, petitions to waive academic decisions saw an overall decrease in numbers, with waiver of required withdrawal regulations decreasing by 35.96% and waiver of debarment regulations decreasing by 42.86%. Requests to waiver Honours standing regulations remained consistent with the 2020-21 trends.

Requests for the pass/fail option also decreased substantially in 2021-22, with a decrease of 65.48%. Prior to 2020-21 the requests for the pass/fail option were uncommon, but it was hypothesized that the heightened awareness of the option caused by the accommodations that were communicated to students for courses impacted by the covid-19 pandemic resulted in an increase in petition requests when university-wide extensions were no longer available. Although 2021-22 did not see a return to the pass/fail option trends prior to the 2020-21 term, the decrease in petition

requests suggests that students may be more familiar with pass/fail option deadlines and criteria and are meeting such deadlines without the need to petition, while also becoming less likely to petition for an accommodation to the eligibility criteria for the pass/fail option.

In contrast to the decreasing petition trends, the Faculty of Health Petitions Committee saw a substantial increase in requests for deferred standing/extension of deferred standing, with an overall increase of 89.66%. In the 2020-21 report, it was hypothesized that the decrease in deferred standing requests during the 2020-21 term could be attributed to the additional accommodations that were made for exceptional circumstances related to the covid-19 pandemic and remote learning conditions. By comparison, the increase in overall deferred standing requests over the 2021-22 term could be attributed to the gradual return to regular deferred standing procedures with fewer exceptional accommodations.

We anticipate that with the return to regular operating procedures at York University, exceptional increases and decreases to petition types by term will be less common and trends will become more consistent over time.

Review of Applications for Tenure and Promotions September 2021 – June 2022:
