Currently our Minor is as follows:

- At least 6.00 credits chosen from 4000 level Global Health core courses.

The above does not include our foundational course: GH 1010 (Foundations of Global Health). Additionally, the courses they may select from are not clearly delineated. In providing the below minor changes, the number of courses would be the same. However, the result would be a student receiving a much more well-rounded understanding of global health. Additionally, the student would be provided with a wide selection, while the course organization would more readily address the Program Learning Outcomes, as the students would now be required to take our foundations courses. We plan to change it to:

The new minor configuration will provide a more comprehensive overview of the program, while also allowing for a scaffolding approach to learning. The required courses, in the first section, provides the foundational base. The second section provides a choice of courses from core global health courses at the 2000- and 3000-level in our BA and BSc programs. The third section provides a listing of core courses at the 4000-level that students have to choose from to complete their two required 4000-level courses. The final section covers a

mixture of our general elective global health courses and Specialized Honours global health stream electives at the 3000- and 4000-level. Through this organization, the students will be certain to take a wide range of courses that provide them with a broad education and understanding of global health, especially its interdisciplinary approach to health.
