Minor Change Description: (e.g. what is the change requested, what does this change mean for the degree, certificate, etc.):

There are two changes being sought:

1. Removing courses from the Criminology extended list

The minor change entails removing 35 courses from the Criminology extended list (i.e., courses that can be taken in other programs and departments, and counted towards the completion of the Criminology degree). For students only majoring in Criminology, they need to complete 12 credits from the extended list; for students doing double majors (CRIM/other major), they need to complete 6 credits from the extended list.

Since students only need to complete between 6 to 12 credits from a list of 113 courses, the proposed change does not affect the way students complete the degree, especially since Criminology majors are unlikely to be enrolled in the specific courses that would be de-listed. Criminology majors have never been guaranteed spaces in these extended list courses (i.e., these courses are not cross-listed between CRIM and other program/departments, nor have other programs/departments provided specific CAS filters to reserve space for CRIM majors) offered by other Departments and Programs across the university. Enrollment has always been subject to the course's availability.

2. Adding an instruction that fourth-year students are not permitted to take more than two CRIM 4000 courses

The requested minor change entails adding the following line to the Notes written under program-specific degree requirements: "Students can take no more than two 6-credit CRIM 4000-level courses". This change ensures that students do not take more than two CRIM 4000-level courses, which has been the informal practice in the program for the past decade. It is an explicit formalization of what is currently an unwritten, informal practice. This minor change will also help the Criminology Program more accurately plan for the number of spaces required for fourth-year students if the program knows that each student is capped at two 4000-level CRIM courses. This explicitly written rule will also help academic advisors guide students' course selection.

Academic Rationale for Change:

1. The removal of courses from the Criminology extended list will enhance curriculum clarity, and help Criminology majors navigate the completion of their degree in a more efficient manner. The courses being removed from this list are ones that have not been offered for at least two years in a row, and/or are courses in which there is no, or very low enrollment of Criminology majors in the past three years. This minor change aims to clarify and clean up the academic calendar copy in order to reduce student confusion (e.g., students who demand to enroll in courses that are not being offered by other programs/departments in a given year, and/or students who do not understand why such course offerings and course spaces are not under the control of the Criminology Program) and enhance curricular clarity. Should Criminology students wish to take courses not on the extended list, they have always been permitted to do so at the Criminology coordinator's discretion. Please note that there has been consultation with the affected programs and departments.

Please refer to the appended table that charts Criminology students' enrollment. The table was prepared using data from the Dean's Office.

2. The addition of an explicitly-written instruction that Criminology majors take no more than two CRIM 4000 seminars is a minor change. Criminology students are required to take between one to two 6-credit 4000-level CRIM courses in the completion of their CRIM major; however, many students often take more than two seminars, even though this exceeds the requirements of the CRIM major. The requested change will serve to formalize what has been an informal practice in the program – that is, an informal practice in which Criminology coordinators have personally written to students enrolled in more than 2 CRIM 4000 seminars in order to persuade them to voluntarily drop one of those seminars from their course selection. Students enrolled in 3 to 4 CRIM 4000 seminars were using those CRIM seminars to fulfill their elective and HBA degree requirements (e.g., 18 credits at the 4000-level). Coordinators were personally making these requests in order to create space for graduating fourth-year CRIM students who were unable to enroll in any CRIM 4000 seminar. Because of the increasing number of requests that need to be made by the Criminology coordinator to specific students, the Criminology Program is currently seeking a formal note because the informal practice is no longer sustainable. As the program has grown in size, the informal practice has become more cumbersome and complicated. As such, the Program would like a formal note in the academic calendar to support Criminology coordinators and academic advisors when they guide students in their 4000-level course selection and enrollment decisions (i.e., when they instruct fourth-year CRIM students to take no more than 2 CRIM 4000 seminars).

Further, the formal note is necessary for the Program to effectively engage in schedule planning. Because of the striking growth of the Criminology program, there has been a large increase in the number of Criminology majors in fourth year. The Program only has the faculty resources to mount a limited number of CRIM 4000 seminars per year. More specifically, the Program has mounted, on average, a maximum of 12 seminars per year over the past 3 years. Because the number of fourth-year CRIM students has consistently increased over the past five years (e.g., from 150 fourth-year majors in 2013/14 to 180 in 2017/18), the Program can now guarantee students space in one seminar per year, and allow many students to take at most two. We can no longer permit fourth-year students to enroll in 3 or more CRIM 4000 seminars as a matter of course, given the limited number of overall spaces. Thus, the formal note in the academic calendar will allow the Criminology Program to more accurately plan for the number of spaces required for fourth-year students if the program knows that each student is capped at two 4000-level CRIM courses.

By taking one to two CRIM 4000-level courses, CRIM students fulfill the following learning objectives of the program: 1) they critically engage with the connections between theory and policy within the interdisciplinary field of criminology, and 2) they develop excellent transferable skills, such as critical thinking, communication, research and writing skills. These courses also aim to help students develop a more specialized knowledge in one to two areas within the field of criminology.

Practically, this minor change will also encourage students to take their 4000-level elective(s) outside of the CRIM program. This in turn will also help achieve the program's learning objectives, by ensuring that CRIM students are able to do the following: 1) develop a uniquely interdisciplinary approach to their topic of inquiry, by learning other disciplinary perspectives and approaches outside of the CRIM program, and 2) understand the boundaries and limits of criminological knowledge, by completing a course outside of their major.
