Minutes of the 117th Meeting of Council June 8, 2023 | Zoom Meeting Room

1. Call to Order

Chair called the meeting to Order.

2. Chair's Remarks

The Chair welcomed members of the Faculty Council (FC) to the $117^{\rm th}$ and last meeting of the 2022-2023 academic year.

The Chair shared that the discussion on possible changes to the Rules and Procedures of Council (2019) with the goal of promoting engagement and participation in collegial governance would continue in the Fall.

The Chair announced that, in the event that the Chair position remained vacant after the meeting, incoming Executive Committee member M. Ebrahimi would be acting Chair of the Executive Committee during the Summer when the Executive Committee would operate under Summer authority, with incoming Executive Committee member R. Ophir serving as back-up acting Chair.

The Chair noted that the acting Vice Chair (VC) for the meeting would be councilor and Executive Committee member A. Solis.

The Chair thanked all councilors, colleagues, and staff for their continued support, wishing everyone a wonderful, re-energizing, and productive Summer.

3. Approval of the Minutes: May 11th, 2023 Faculty Council Meeting

5. Reports of Standing Committees of Faculty Council

Executive Committee: Elections and Nomination Period

The acting VC presented the Executive Committee report on the current vacancies and stressed the need to fill the Chair of FC, Vice Chair of FC, and other vacancies on LA&PS and Senate standing committees.

The VC called for further nominations from the floor of FC. Councilor B. Spotton Visano nominated herself for the Senate Executive Committee vacancy.

Motion: to close the 2nd round of elections and nominations. Moved, seconded, and unanimously approved.

The acting VC announced that, following the closure, there would be acclamations and elections from June 15 to June 22, 2023; there would then be a 3rd round of nominations for the remaining vacancies with closure on the floor of the first FC meeting in Fall 2023.

• Graduate Committee: Consent agenda

Having received no objection the consent agenda, it was deemed approved.

• <u>Item for Information: Year End Report of Curriculum, Curricular</u> <u>Policy & Standards committee</u> Council member T. Abbruzzese presented CCPS year-end report to FC. CCPS Chair shared that an email had been sent to departments regarding new procedures and forms for requesting changes to new and existing course proposals, degree changes, and minor changes, with the submission deadline extended from June 1, 2023, to June 19, 2023.

Item for Information: Year-End Report of Academic Policy & Planning Committee

Council member A. Glasbeek presented the year-end report to FC. The first order of business, the ongoing budget governance-related motion/memo, was recently moved to Senate, requesting all LA&PS senators to speak to it when on the Senate floor either this month or sometime in the Fall.

The LA&PS Academic Plan 2021-2026 survey was sent to Chairs and Directors this Summer. This is preliminary work being done to help facilitate the renewal of this document in the coming two years.

Markham Deputy Provost G. Binsted was invited to the June 2023 APPC meeting to answer questions related to LA&PS-Markham resource allocations and governance.

A. Glasbeek thanked staff for their support to the committee.

Item for Information: Year-End Report of Committee on Research
 Policy & Planning

Council member X. Yu presented the year-end report to FC. CRPP Chair shared that CRPP had been busy this year with work on the SRP 2023-2028 and the adjudication of Minor Research Grants and Deans Awards for Distinction in Research. Furthermore, the committee worked on a new interdisciplinary research award currently awaiting LA&PS Dean's approval.

X. Yu thanked all committee members including the two students, AD de Costa, and the Research Office for their guidance and time. X. Yu thanked FC Office staff for supporting the committee.

Item for Information: Year-End Report of Tenure & Promotions <u>Committee</u>

Council member B. Spotton Visano presented the year-end report to FC. A council member raised concerns about SRC file delays and procedural issues. B. Spotton Visano shared that the SRC delays from previous years were being addressed this year and that the committee was set to clear all backlogged files effective June 2023. B. Spotton Visano thanked FC Office staff for their support.

7. Item for Information: Decanal Renewal (Provost Lisa Philipps and Jessica Wyman, Senior Academic Policy & Recruitment Officer)

Provost L. Philipps praised all for participating and helping organize the Congress of Humanities and Social Sciences 2023 held at York University. It was an absolute privilege hosting a successful event of this magnitude with 10,000 plus attendees.

The Provost presented updates on the LA&PS decanal renewal process and thanked all who had responded to the survey circulated by the Office of Institutional Planning and Analysis. A senior LA&PS faculty member reviewed all the data and summarized them for the President and Provost. The Provost thanked Professor A. Solis who had performed the review function.

The Provost concluded by adding that the President and the Provost were satisfied with all the input they had received. The final decision rested with the Board of Governors. The Dean's 2nd term renewal

recommendation would be presented on June 27, 2023, after which the final announcement would follow.

8. Dean's Report to Council: Budget Update

Dean McMurtry presented the current budget and enrollment updates and made note that these current numbers would be in flux and subject to changes as student admissions and enrollments would be finalized throughout the Summer months.

The Dean shared that there was no trend toward one type of program/study. The final comparator OUAC numbers would be released in a few weeks for strategizing and analysis.

The central decided to rebate a portion of the University Funds contributions back to the Faculties. The Dean informed members that the Faculty presented a 3-year rolling budget over three fiscal years, the current proposed budget was pending approval, and FC members were urged to review the budget presentation. Dean McMurtry mentioned that new hires, constructions, renovations, and equipment renewals might be delayed.

ITEM FOR ACTION (1):

1. Nominations – Liberal Arts & Professional Studies Council Standing Committee & Representatives on the Academic Policy, Planning and Research Committee – Starting July 1, 2023

The nomination period, which ran from June 9 to September 14, 2023, sought to fill 1 vacancy for the LA&PS Representatives on the Senate Academic Policy, Planning and Research Committee and 20 vacancies on the Faculty Council Standing Committees. The Executive Committee recommends the following slate of nominations for a term effective July 1, 2023. Elections will be held for nominations in LA&PS Representative on the Senate positions and the Committee on Curriculum, Curricular Policy and Standards. Nominations are also accepted from the floor of Council. Council Committees which received fewer nominations than the available vacancies will follow the acclamation process. Final approval for the slate of nominees is given by Council on a motion that nominations be closed, as moved by the Vice-Chair of Council.

1. Elections Results – Liberal Arts & Professional Studies Council & Standing Committee and LA&PS Representatives on the Academic Policy, Planning and Research Committee – Starting July 1, 2023

Elections for membership Council Standing Committees and LA&PS Representative on the Senate Academic Policy, Planning and Research Committee (APPRC) opens on September 14, 2023 and closes on September 21, 2023. In accordance with its responsibilities, the Executive Committee will review the election results and, in cases where nominees had been elected to more than one committee, assigned these faculty members to the committee with the greatest need. Due to many vacant position and an absence of Chair within APPRC, the Senate has requested for an expedited elections process and the need to communicate the LA&PS Senate representatives before the second meeting on September 28, 2023. The Executive Committee will announce the results of the 2023-2024 LA&PS Senate representative Elections on September 27th, 2023 via email. The elections results for the 2023-2024 Council Standing Committee will proceed in accordance to LA&PS standard practices. The list below (Appendix A) contains the new and continuing members for each committee.

Chair of Council

- The Chair of Council shall be elected from the members of the Council for a one-year term; either by e-ballot in the event of at least two nominations have been submitted, or by acclamation.
- The Chair shall conduct the proceedings of Council in conformity with the rules and procedures enacted by the Council.
- The Chair shall hold the position for a term of one (1) year, defined as one academic year and ending upon June 31st, 2024. Therein the Vice-Chair shall succeed to the position of Chair.

DRAFT: Year-End Report of the Committee on Teaching, Learning, and Student Success, 2022-2023

Note: this is a draft and not the actual year end report.

The Committee on Teaching, Learning, and Student Success (CTLSS) met nine times between September 2022 and May 2023. The June meeting was cancelled as there was no pressing business.

Changes to staff and membership

Robert McKeown assumed the role of Chair for CTLSS in July 2022, succeeding Natalie Neill. The Chair expresses gratitude to Michele Johnson, the Associate Dean of Teaching and Learning, and the Associate Dean of Students, for their invaluable monthly reports and exceptional leadership within the Committee. Gail Vanstone and Carolyn Steele, both from the humanities, joined as new faculty members, replacing the outgoing members Sivran Karimi and Natalie Neill. Additionally, Linda Hargreaves joined as the representative for contract faculty. Regrettably, CTLSS lost the insight of faculty member Robert Kennedy following his resignation in December. The Committee welcomed Sheril Hook, Associate Dean, Teaching and Learning representative from the Learning Commons who replaced Sophia Bury. CTLSS welcomed Mandy Frake-Mistak, Associate Director of Program Evaluation and Pedagogical Design and Tejas Kittur, Manager, Faculty Governance and Administration, who worked with Keelan Atkinson to organize our monthly meetings. The Chair was on parental leave from January to March, so Glenn Goshulak acted as Chair until his return in April.

Summary of projects and initiatives

Guide to academic honesty

During the November meeting, Angela Clark, the Academic Integrity Officer from the Office of the Vice-President Academic (VPA), along with Angelica McManus, the Coordinator of Student Awards and Academic Integrity, Lavina Sadhwani, another Coordinator of Student Awards and Academic Integrity, and Spencer Wagner, the Manager of Petitions and Academic Integrity, presented a comprehensive working document entitled "Best Practices Guide for Handling Academic Honesty Cases." This document was designed to facilitate the efficient handling of academic integrity complaints by providing valuable insights and inviting feedback from various stakeholders, including Course Directors (CDs), Undergraduate Program Directors (UPDs), Department Chairs, and staff. The primary objective of this guide is to enhance the understanding of the decisionmaking process of Academic Honesty cases at the faculty level, thereby fostering a stronger connection between policy and practice while ensuring transparency in promoting academic honesty. The guide not only addresses the intricacies involved in the academic honesty process but also offers valuable best practices and resources to aid stakeholders in navigating the process more effectively. The authors of the guide were Clark, McManus, Sadhwani, and Wagner and they received input from Glenn Goshulak and Robert McKeown. The guide was renamed the "Committee on teaching, learning and student success: guide to academic honesty" and received the endorsement of CTLSS during the December meeting. Subsequently, it was disseminated to all Chairs and UPDs within LA&PS.

Digital learning strategy guidelines

To establish guidelines for a comprehensive digital learning strategy within LA&PS, a new subcommittee was formed in Fall 2022. The resulting document, titled "Guiding considerations for a technology-enhanced teaching and learning plan in LA&PS," reflects the diverse range of values and guidelines that exist within different teaching contexts, representing a broad spectrum of approaches. The primary objective of this guiding document is to envision the possibilities for teaching and learning practices within LA&PS by orienting staff, CDs, UPDs, and Chairs to explore potential avenues for innovative pedagogical practices including fostering collaboration within new or existing communities of practice. This document aligns the LA&PS community with the values outlined in the LA&PS Academic Plan 2021-2026 and the York University Academic Plan 2020-2025.

Specifically, this document:

- extends tech-enhanced teaching and elearning practices beyond mere emergency response;
- supports meaningful and authentic learning experiences, both online and in-person;
- inspires instructors to create innovative learning experiences that leverage technology like digital whiteboards, iClickers, and others in online, blended, or hyflex courses;
- promotes a learner-centered approach to prioritize student engagement;
- provides practical considerations and resources for teaching and learning;
- takes a small, first step towards a more formal digital learning strategy.

In March, CTLSS granted approval for this document to be forwarded to the Faculty Council. Mandy Frake-Mistak and Robin Sutherland-Harris led the preparation of the document, incorporating valuable insights from Hilary Davis, Anita Lam, Carolyn Steele, Gail Vanstone, and various other current and former members of CTLSS.

Food security

A well being survey for Canadian universities found that 45.55% of surveyed students within LA&PS are restricting their food intake due to a lack of funds. Additionally, 37.31% of LA&PS students reported suffering from hunger due to the food insecurity, with a total of 30% suffering from low to very low food security. LGBTQIA2S+ and racialized students have poorer than average food security outcomes, with transgender and nonbinary students having the lowest food security outcomes. Economic pressures are a major influencer on food security with students working 20-30 hours a week often having lower than average food security. Food prices have inflated more than 10% since March 2022, which does not help the situation of our students.

In recognition of the severity of food insecurity, CTLSS drafted and approved a letter outlining the severity of the situation which was sent to [].

Feedback on draft of Senate academic conduct policy and procedures

CTLSS expressed deep concern regarding the proposed changes to the *Senate Academic Conduct Policy and Procedures* from November, as it anticipates adverse effects on teaching and learning. Of particular concern is the potential elimination of the current academic misconduct procedures within LA&PS. CTLSS firmly stands in support of the feedback submitted by LA&PS Chairs to the Senate, reflecting our shared apprehension toward having CDs resolve academic misconduct cases. Within LA&PS, charges of academic misconduct are currently resolved at the Department or Faculty level due to three key reasons:

- Student rights: Recognizing the inherent power imbalance between students and course directors, the resolution of academic misconduct cases at the Department or Faculty level ensures that students' rights are safeguarded and the process is fair.
- Consistency in penalties: UPDs play a crucial role in conducting exploratory meetings to ensure consistency in the application of penalties for academic misconduct.
- Workload considerations: Taking on the responsibility of resolving academic misconduct cases represents an additional workload for course directors, so compensation for a new role should be addressed.

In March, CTLSS took action by sending a letter outlining these concerns to Senator Puri, Senator Bunch, and Members of the Academic Standards, Curriculum, and Pedagogy Committee.

Design principles for active learning spaces

The document titled "Design Principles for Active Learning Spaces" provides valuable guidelines for designing classrooms that align with the objectives of the LA&PS Academic Plan 2021. Traditional classrooms, such as large lecture halls, typically foster a top-down instructor-student dynamic, where students assume passive roles and instructors function as the authoritative "sage on the stage" (King, 1993). However, by reimagining the layout of these traditional spaces, environments that promote active learning can be created which empower students to engage in hands-on, collaborative activities. Active learning classrooms (ALCs) offer numerous benefits by facilitating the widespread adoption of active learning strategies. Research indicates that the physical attributes of a classroom have the potential to create affordances that promote student engagement (Rands and Gansemer-Topf, 2017, p. 31). The configuration of ALCs can vary based on available resources, existing infrastructure, pedagogical goals, and student needs. The LA&PS document recommends classroom designs that focus on flexibility, accessibility, interaction, safety, and technology. Anita Lam authored the document, which received endorsement from CTLSS in April.

Additional activities

During the period of campus closure and forced transition to online classes from 2020 to 2022, a large number of academic integrity cases were brought forward. The result was a significant, sometimes overwhelming, backlog of academic honesty cases. Thanks to the tireless efforts of CTLSS members, the backlog was eliminated in October.

A subcommittee of Robert McKeown, Robin Sutherland-Harris, and Sheril Hook was formed to suggest revisions to the Dean's Award for Excellence in Teaching to simplify the nomination package for contract faculty and teaching assistants.

During our April meeting, committee members volunteered to adjudicate the student awards, and Karen Ruddy volunteered to serve as Chair of the adjudication sub-committee for the 2022-2023 Dean's Awards for Teaching Excellence.






Importance of the Reputation Ranking and survey participation



Maclean's - University Rankings (10 Year View)


Comprehensive Category - 15 universities






Maclean's - Reputation Rank (2013 – 2023)



Remarks

Minutes will be amended accordingly.

Reports

Under President's items, President Lenton spoke to the following:

- Acknowledged the attack at University of Waterloo and expressed sympathy and solidarity.
- Expressed thanks for Senators who attended convocation.
- Highlights of achievements to Plan (UAP priorities), including more than 99% achievement for performance metrics in Year 3 of the Strategic Mandate Agreement. In 2023-24, the provincial government will begin to link funding to achievements.

The President's monthly "Kudos" report on the achievements of members of the York community was received.

Senate approved a slate of candidates presented by the Executive Committee with the result that several individuals were acclaimed to positions on Senate committees.

Committee Information Reports

Executive Committee

The Vice-Chair, Lauren Sergio, highlighted the following items in the information report:

- Summer Authority coming into effect, after this meeting until Senate convenes in September.
- The planned in-person meeting of Senate in September.

Academic Policy, Planning and Research Committee (APPRC)

The Chair of APPRC, Senator Moir, highlighted the following items in the information report:

• The provost and vice president academic, and the vice-president finance and administration (VPFA) presented in tandem to APPRC on 15 June on the operating budget context for academic planning.

APPRC in turn, facilitated an annual update to Senate on the budget context, presented by the Provost and the VPFA.

Academic Standards, Curriculum and Pedagogy Committee (ASCP)

The Chair of ASCP, Senator Bunch, highlighted the following items in the information report:

- Continuation of revisions to the *draft academic conduct policy*. Revisions are being undertaken by a working group comprising members of ASCP, SAC, and past working groups. The revised draft document will be posted on the ASCP page on the Secretariat's website for community review and comments. It's anticipated that the document will be presented to Senate in the fall.
- University practices related to *attending physician's statement for students* are under review with related draft document to be shared with the community for feedback.
- Minor changes to admissions requirements for graduate degree programs listed in the ASCP report to Senate were not approved by ASCP and as such will be excised from the report.

Senate approved the following motion:

Considering the unrecognized impact of the recent revisions to the Senate Policy on Sessional Dates and the Scheduling of Examinations (May 2022), it is recommended that Senate request that the University Registrar in conjunction with the Senate ASCP Committee:

- make an adjustment to the Winter 2024 term dates to achieve a consistent structure of 12 meets for each course, and
- further review and undertake consultations with the Faculties to gather input on the implementation of the Sessional Dates policy to ensure that there is consistency in the number of class meets in the fall and winter terms, and to the extent possible in the summer session terms, for the previously announced sessional dates through to FW 2028-2029.
