have min. 10 years of work experience in the broader public/NGO sector.



#### **Executive Director and General Counsel - Black Legal Action Centre**

The Black Legal Action Centre (BLAC) is an independent, non-profit community legal clinic with a mission of combatting individual and systemic anti-Black racism by providing legal services to members of Ontario's Black communities, including engaging in advocacy, community development, law reform, test case litigation, and public legal education. BLAC is funded by Legal Aid Ontario (LAO) and governed by a volunteer Board of Directors. The Executive Director will lead a team of legal and other staff and volunteers to ensure the implementation of BLAC's strategic plans, goals and objectives.

#### **Advisor, Strategic Policy - Ontario Energy Board**

The OEB are current seeking a collaborative individual to join their team as an Advisor in the Strategic Policy department. In this role, you will be responsible for assisting in the development and implementation of OEB policy initiatives. The role contributes to the development of policy insight through qualitative and quantitative research and analysis to support decision making.

#### **Project Lead, Solid Waste Management - City of Toronto**

The project lead:

- Provides policy analysis, planning and research expertise to senior management of the Division/City as it relates to the Long Term Waste Management Strategy and existing waste diversion programs.
- Leads and implements projects that examine policy options including developing policy responses, research and developing implementation plans of new waste reduction and resource recovery policies.
- Oversees policy research and analysis into assigned area ensuring that such research takes into account developments within the field, relevant waste and environmental legislations, regulations, corporate policies and practices, and by-laws.
- Formulates, influences, critiques and evaluates waste management policy positions and frameworks for implementation by the Division/City and other government levels.

#### Senior Advisor, Nuclear Energy Technologies - Ontario Ministry of Energy, Northern Development and Mines

In this opportunity in the Nuclear Supply Branch, Energy Supply Policy Division, you will provide advice, analysis and expertise in the development of public policies and strategies related to nuclear energy technologies in Ontario. Provide expert advice and guidance related to economic, regulatory, environmental and social considerations of nuclear energy supply in Ontario (e.g., nuclear generation projects, long-term management of nuclear waste, emerging trends and technologies in the nuclear sector). Assess the impact of initiatives and analyze and develop public policy options and strategies with respect to nuclear energy in Ontario taking into consideration economic, regulatory, environmental and social impacts. Provide policy recommendations based on research and analyses of complex technical, regulatory and economic aspects of nuclear energy. Present recommendations to senior management and suggest strategies with policy or regulatory alternatives.

#### **Bilingual National Coordinator - OCASI**

The coordinator will lead a project to organize racialized and im(migrant) and refugee women's groups (English and French) to explore interest and viability to convene a national network. The Bilingual National Coordinator will be responsible for conducting a literature review and environmental scan, developing a database of groups, convening regional and national roundtables and co-creation of a network charter. The project will be carried out using a feminist anti-racism and anti-oppression framework. The project will conclude in December 2022. While priorities and focus will be determined by network members, candidates should be grounded in a strong understanding of policy and advocacy to support the work of the network.

#### <u>Director, Communications and Stakeholder Relations - Alliance for Healthier Communities</u>

The Alliance for Healthier Communities is hiring a Director, Communications and Stakeholder Relations. This position will monitor and respond to relevant government activity, analyze government legislation and regulation that impacts the Alliance for Healthier Communities (Alliance) members and clients, develop and implement advocacy and communications strategies to advance the Alliance's strategic plan, and ensure the high quality delivery of the Alliance's public policy agenda.

#### **Evaluation Manager - Shared Services Canada**

Shared Services Canada (SSC) provides IT infrastructure and services for departments and agencies in the Government of Canada. It is playing a central role in delivering on the Government of Canada's digital vision by building a modern, reliable, and secure digital platform for the delivery of programs and services for Canadians. The COVID-19 pandemic has hastened the pace of change and is fostering the development of new "digital first" strategies. After COVID, many Canadians will not want to go back to lining up at service counters to access government programs. More and more services will need to move online and there will be greater expectations among Canadians for access to government services through mobile phones and other devices. Within the Public Service, the Government of Canada is actively encouraging telework as departments plan for the eventual return to workplaces. In light of these operational and strategic realities, SSC is building a best-in-class evaluation function. SSC's growing team of professionals provides neutral and independent assessments of the relevance, effectiveness and efficiency of SSC programs for the President and the Executive Board. Their analyses and recommendations help to inform key decisions for the department, add value to SSC clients, and improve the delivery of services and results for Canadians.
