#### What is the National Student Paper Competition?



# Share your thoughts on labour protections in Canada

The Government of Canada knows that labour protections must continue to evolve to ensure safe and decent working conditions now and into the future. To ensure that labour protections keep up with the rapid pace of change, the Government wants to better understand:

- the experiences of gig workers (workers who enter into shortterm contracts to complete specific and often one-off tasks) in federally regulated sectors, including those who work through digital platforms like delivery or freelance applications; and
- how federally regulated workers could benefit from a "right to disconnect" policy (for example, by having clear expectations around the use of cellphones after the workday is done).

The COVID-19 pandemic has exposed both the vulnerability of gig workers and Canada's dependence on them to provide essential services. Furthermore, the fact that that more Canadians are now working from home as a result of the pandemic is blurring the lines between what it means to be "at work" and "not at work."
