### Research Spotlight

**SPPA Professor Ian Stedman** and a team of researchers at the University of Toronto and SickKids Hospital were recently awarded a 4-year Canadian Institutes of Health Research (CIHR) Project Grant for \$634,952.00. The Project [Equitable Child Health: Enabling broad ethical inquiry in pediatric care by understanding the parameters of social license for reuse of clinical data](#) will determine the context under which research using children's data is acceptable to the public, and how people's opinions vary according to their identity.

The interdisciplinary team consists of Dr. Alistair Johnson (University of Toronto, Scientist, Child Health Evaluation Science at SickKids and Infrastructure Co-Lead at the University of Toronto Temerty Centre for Artificial Intelligence Research and Education in Medicine) and Dr. Melissa McCradden (University of Toronto, Bioethicist at SickKids) and Dr. Mjaye Mazwi (University of Toronto, Critical Care Physician, Co-Lead Artificial Intelligence in Medicine for Kids at SickKids).

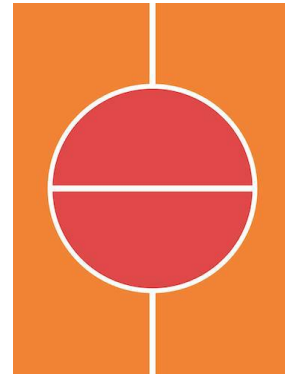

### Our Age of Anxiety and the Rule of Law

Many people all around the globe feel uneasy, lost and anxious. A major contributor to our great unease is a widely perceived deficit of political legitimacy that has made it easier for populist nationalists to undermine liberal democracies. To address that anxiety we must restore belief in our collective ability to build healthier societies. We need to do two things. One is to draw upon our shared history of making progress, flawed though the contemporary reality may be and will always be. The other way is to embrace an action-oriented pragmatist ethos. That ethos is particularly important as we seek to restore belief in the rule of law. The rule of law is one of the great achievements of the modern world. Yet it is under deep threat. We need to reconstruct a rule of law for today, using our inherited intellectual resources. I propose a recalibrated and revitalized rule of law for our age of anxiety.



**STEPHEN J. TOOPE OC, LL.D.** is 346th Vice-Chancellor of the University of Cambridge, the first non-UK national to hold the post. He was Director of the Munk School of Global Affairs at the University of Toronto, and President, the University of British Columbia. A former Dean of

Enforced and Involuntary Disappearances. Toope publishes in global journals on human rights, international dispute resolution, international environmental law, the use of force, and international legal theory, and has lectured at universities around the world.
