I have learned many important lessons that I now try to apply to my own teaching. My courses are designed to meet the needs of all students. While there are clear learning outcomes, they are best met when I, as a teacher, adapt to my students instead of them adapting to me. I provide students with the instruments that they need to succeed; I suggest that the know-how and the development of soft skills are as significant as any content I could teach. I provide students with as many opportunities as possible to reflect on their learning and to grow and develop as human beings. Finally, I believe that the best teachers listen and exercise humility and empathy.



I approach my teaching through the lens of my experiences - that is, I attempt to provide as complete a learning context as I can, so that students can better appreciate the theories and concepts of public policy and administration, how they were pertinent in my time in public service, how they apply today by way of assessing selected current developments, and engaging students in inquiry as to what may behind important public policy be

In some instances, I can illustrate and amplify the concepts having experienced them firsthand, such as the notion of new public management or the delivery of infrastructure projects through the means of public private partnerships. I invite guest speakers, distinguished current public servants to share their reflections with students as well. These strategies provide an opportunity for students to engage in a deeper awareness of how context, developments in governance, competing priorities, political objectives, international obligations, social media, and a host of other factors impact public policy and administration. There are few things more rewarding for a teaching practitioner than to watch a student grow in confidence, capability, and potential for positive impact when they take full advantage of the learning environment that is available to them in the university setting.

The purpose of Melodie's exploratory qualitative study was to gain insight into how hybrid work has impacted working mothers in the Ontario Public Service. The results of her study confirm that the reported impact depended on what phase of hybrid work was being discussed, with different challenges occurring earlier in the COVID-19 pandemic compared to the current time. Melodie had the opportunity to present her paper to the <u>CAPPA/IPAC National Thought Leadership</u> Award panel and was the runner-up, taking silver in the competition.

Professor Kapralos and her teams at the OPS worked on two projects — the Justice of the Peace and Judicial Appointments Advisory Committee Modernization (JPJAACM), and in partnership with the Ministry of Public and Business Service Delivery (MPBSD), the Notaries and Commissioners Modernization Team (MNCMT) — and were nominated for Amethyst Awards in the category Digital Disruption Group.

The Amethyst Award recognizes outstanding achievements by Ontario public servants, including individuals, groups and partnerships. Candidates are nominated by their peers, approved by their Deputy Ministers, and recipients are recommended by an independent selection committee appointed by the Secretary of Cabinet. JPJAACM's creation of the first ever entirely digital process for judicial and JP recruitment in Ontario, and the leadership the MNCMT displayed in the successful legislative and regulatory reform for modernizing legal documents and processes, putting Ontario in the forefront, are indeed outstanding achievements.

Help our students learn from you!

You are invited to nominate and host experiential education projects for take-up by our undergraduate students at the School of Public Policy and Administration (SPPA) during the Fall 2023 - Winter 2024 academic terms.

SPPA delivers <u>Experiential Education Courses</u> in policy analysis and program evaluation, among others, that have a track record of working with public sector organizations and achieving results.

Core experiential learning assignments are featured in **PPAS 4200 Applied Public Policy Analysis and PPAS 4310/20 Program Evaluation I & II in particular.** In these courses groups of fourth-year students advise on client projects, culminating in presentations and/or reports by April 2023. Host organizations are consulted on project requirements and interim milestones once their project is selected. Any project costs for these pro bono engagements are nominal.

This initiative offers practical benefits for government, non-profit organizations and SPPA. Students look to learn from the real challenges of project choice, complexity, and management. At the same time, the projects enable host organizations to tackle pressing issues in times of uncertainty and change.

SPPA profs launch book on international relations!

SPPA Professors <u>Ian Roberge</u> and <u>Thomas Klassen</u> in collaboration with Professor Nara Park at Yonsei University in South Korea, have co-edited a newly published book on international relations and the turbulent dynamics existing between neighbouring countries of disparate size and political influence: <u>Asymmetric Neighbors and International Relations Living in the Shadow of Elephants</u> (Routledge, 2023). The book studies a multitude of relationships between a small country and its more powerful neighbour. Individual chapters examine Canada and the U.S.; New Zealand and Australia; Belarus and Russia; Qatar and Saudi Arabia; Colombia and Brazil; and others.

Expert In Inclusive Provisions In International Trade Agreements - Expert Deployment Mechanism For Trade And Development

The technical expert will prepare a research paper on the inclusive trade provisions in trade agreements, including the history, current trends, substance, legal effect, impact and gender equality and social inclusion considerations of these provisions. This research is expected to include secondary (comprehensive literature review) and primary (surveys, key informant interviews) sources. Based on the evidence collected in the research, the experts will identify options and challenges, best practices and opportunities to promote inclusiveness in trade agreements better.

Tourism Development Expert - Expert Deployment Mechanism For Trade And Development

The expert will be responsible for activities such as preparing an inventory of the existing inclusive tourism offer in six regions of Colombia, including through desk research, surveys, site visits and in-person meetings with regional tourism authorities and tourism service providers. The inventory will include tourism services tailored to the needs of women in all six regions and to the needs of LGBTIQ+ tourists in three regions (Gran Caribe Colombiano, Andes Occidentales and Andes Orientales) and preparing an analysis of the Canadian market for inclusive tourism services and an overview of inclusive tourism programs and policies in Canada;

Expert in environment and climate change provisions in trade agreements - Expert Deployment Mechanism for Trade and Development

The suitable candidate will be responsible to prepare a research paper on the environment and climate change provisions in trade agreements, including the history, trends, substance, legal and institutional effect, impact and gender equality and social inclusion considerations of these provisions. The paper should include an examination of FTA provisions within environment and climate change chapters, or side agreements, and those in other chapters that affect the environment and climate change impact of the agreements. The research is expected to include secondary and primary sources. Based on the evidence collected in the research, the experts will identify options and challenges, best practices, and opportunities better to integrate environmental protection and climate change into trade agreements.

Public Policy and Advocacy Specialist — Malvern Family Resource Centre (MFRC)

Reporting to the Youth Manager, you will lead the implementation of the Malvern Youth Advocacy and Action Program (MYAAP) from inception, working alongside passionate youth change makers in the area of education and housing policy. The officer will be accountable for the complete RFx process from scope of work (SOW) creation through to evaluation, negotiation, and purchase order award process, including performing the commercial evaluation, and ensuring the integrity of the procurement process aligning with NWMO governance.

Senior Advisor, Regulatory Affairs - Nuclear Waste Management Organization

Reporting to the Manager, Licensing, the successful candidate will be a member of a dedicated team responsible for the impact assessment and CNSC license for a deep underground geological repository. This position will provide leadership and direction in the development and implementation of processes that will enable the NWMO to receive and maintain all required permissions and approvals from the government departments and ministries (Federal and Provincial) and that will enhance regulatory certainty, compliance and efficiency.
