

Application period: October 12, 2023 to December 19, 2023

Seize the opportunity to bring your projects to life and help youth reach their full potential. The Government of Canada is inviting all youth-serving organizations to apply for funding. Through this initiative, CSC provides volunteer service opportunities for youth ages 12 to 30, fostering impactful community change, skill development, and lifelong civic engagement. Exciting updates to CSC this year will make it easier for organizations to participate and will expand youth eligibility, including youth as young as 12 in certain program streams. This CFP also aims to expand and diversify CSC programming, and ensure youth, particularly Indigenous and under-served youth, have access to meaningful volunteer opportunities that will help them shape their development and growth. Organizations interested in applying for funding are encouraged to create an account through the Grants and Contributions Online Services (GCOS) portal.

Eligible recipients for this CFP include: not-for-profit organizations; for-profit organizations (provided that the nature and intent of the activity is non-commercial and not intended to generate profit); research organizations and institutes; Indigenous organizations (including band councils, tribal councils and self-government entities); and municipal, provincial and territorial *entities, including institutions, agencies and Crown corporations, public health and educational institutions. This CFP prioritizes projects that have a focus on one or more of these themes: reconciliation; building an inclusive Canada; preserving the environment; promoting civic and democratic engagement; strengthening youth resilience; and/or potential new themes identified by youth. Australian National University Migration Update - School of Regulation and Global Governance

The event will explore the latest research and policy priorities surrounding human migration at the local, national and global levels, from an Australian perspective. The event will feature keynote speakers from academia, government, international organizations. IOM's **Marie McAuliffe** (Head of the Migration Research and Publications Division) and **Jacqueline Weekers** (Chief of Mission for Australia and Coordinator for the Pacific) will be among the speakers.

Policy Advisor, Cultural Policy Hub – OCAD University

The Policy Advisor supports the research, writing and knowledge mobilization for OCAD University's Cultural Policy Hub, a collaborative conduit of cultural stakeholders and partners from across Canada. The Hub aims to facilitate and expand the arts and culture sectors' capacity in policy research, data analysis, program design and development, and facilitate more frequent knowledge exchange and mobilization. The Policy Advisor will conduct research for, as well as write and edit, policy documents and related communications content for the Hub and its website that support the governance councils and leadership priorities. They will also initiate and conduct policy research in identified areas, with a focus on policy related to creative entrepreneurship and skills development.

Project Manager (Community Infrastructure Unit) – City of Toronto

As part of Social Development, Finance & Administration, the Project Manager will lead the development, implementation, and ongoing evaluation of key initiatives in the Community Infrastructure Unit, including neighbourhood plans, new community space, and community hub facilities, and aligned City programs and initiatives. The successful incumbent will be an experienced project manager with an equity-centred approach and will support the Division and City in advancing strategies to improve equitable opportunities for Torontonians. The Project Manager recommends project and program goals and strategies, conducts research into assigned areas, and provides expertise and technical assistance to diverse stakeholders.

Policy & Program Advisor – City of Toronto

As part of Toronto Water Infrastructure Management, the Policy & Program Advisor develops new policies, guidelines, and standards related to the construction and operation of sanitary, stormwater, and water supply infrastructure. The Policy & Program Advisor will also support and undertake studies to inform policy direction and guide infrastructure planning. Responsibilities include conducting research on best practices, legislation, applicable policies and practices, and operational impacts, and ensuring programs policies and procedures are consistent with Council direction and provincial and federal legislation.

Management Consultant - City of Toronto

The Technology Services Division of the Office of the Chief Technology Officer is hiring a Management Consultant to lead complex technology strategy and planning assignments and initiatives, including for the Connected Community program. The Management Consultant will develop and deliver complex policy guidance and implementation plans on a range of topics including emerging technology, artificial intelligence, digital equity, and data governance. They will also contribute to the development and implementation of strategic organization design and effective governance on matters related to the ethical use of technology, privacy, cybersecurity, data governance, intellectual property, and innovation.

<u>Police Complaint Commissioner – Legislative Assembly of British Colombia</u>

The Police Complaint Commissioner is a non-partisan, independent statutory officer of the Legislature, with a mandate under the Police Act to provide impartial civilian oversight of complaints regarding the conduct of municipal police officers in

British Columbia. The Commissioner heads the Office of the Police Complaint Commissioner with headquarters in Victoria.

The Office has an annual operating budget of \$7.2 million and approximately 40 full-time equivalents.

Policy Analyst, The Dais - Toronto Metropolitan University

The Policy Analyst will be responsible for producing quantitative and qualitative research, analysis, and written product, in support of building a robust, data driven and equity-informed picture of major issues related to innovation and technology policy in Canada, and of how Canadians from different communities interact with this landscape. The Policy Analyst will develop actionable policy recommendations and inform the design and delivery of pilots, programs, and other initiatives related to public policies that impact the responsible adoption and governance of technology.

Policy and Advocacy Lead (Bilingual Position) – Alliance for Healthier Communities

The Policy and Advocacy Lead is responsible for supporting the CEO on high-priority matters relating to the policy direction and strategic initiatives of the Alliance. This includes participating in meetings, identifying actions, and executing the work which will involve a combination of hands-on support, collaborating across teams, managing linkages across the organization as well as liaising with members and provincial partners. The Policy and Advocacy Lead identifies and acts on policy and legislative issues impacting members, contributes to briefing notes, presentations, reports, and other policy products, and develops tactics related to legislation, position statements, member needs, and strategic relationships. This position is also responsible for executing the strategies to enhance Francophone access to services, as well as francophone and bilingual membership's positioning in Ontario.

Senior Policy Advisor – LCBO

Reporting to the Senior Manager, Policy and Stakeholder Relations, the Senior Policy Advisor leads complex policy initiatives, provides expert policy advice, guides other advisors/analysts, and consults with internal and external stakeholders to support LCBO policy development and the implementation of changes to the beverage alcohol marketplace in Ontario. This includes reviewing and evaluating government and trade proposals to assess impacts to LCBO policies and programs and working collaboratively with stakeholders to address any concerns.

Senior Vice-President, Corporate Services & Chief Financial Officer – St. Lawrence College

Reporting to the President and as a member of the College's Executive Team, the Senior Vice-President, Corporate Services & Chief Financial Officer ("SVP") provides collaborative corporate leadership and decision making across the entire College and its three campuses. As a senior leader of the College, they will have responsibility to advocate for and lead with diverse perspectives, including Indigenous Ways of Knowing and Being. Leading a dedicated team of experts, the SVP oversees and directs a complex and large portfolio comprised of; Risk Management; Financial Services; Information Technology Services; and Facility Management Services. In the capacity as the Chief Financial Officer, the SVP provides financial leadership to the College and its Board of Governors and holds the appointment as Treasurer on the Board.

<u>Senior Financial Analyst – Ontario Treasury Board Secretariat</u>

The Controllership Policy and Accounting Consultation Branch is looking for a hardworking and driven individual with a passion for public service and technical accounting. As a Senior Financial Analyst, you will be a key member of a dynamic and fast-paced team, leading the implementation of new accounting standards across the government as well as the development and execution of controllership policies (accounting, business finance and control) for the Province to promote effective financial management and accountability.
