





He served as Pakistan's first Foreign Minister, President of the UN General Assembly, and President of the International Court of Justice. A prominent figure in international law and diplomacy, he upheld justice, governance, and public service throughout his career. As a member of the Ahmadiyya Muslim Community, he championed values of service, knowledge, and human rights. He also translated the Holy Quran into English and authored a seminal work on Islam and human rights.

#### Volunteer with Re-Cup: A Campus Sustainability Research Project

Looking to take action for the planet while gaining hands-on experience in sustainability and public-facing research this summer? The Re-Cup Project is recruiting volunteers to support a waste-reduction initiative right here at York!

Every day, thousands of coffee cups disposed of in York's recycling bins end up in landfills due to contamination and material issues. The Re-Cup Project — a sustainability research initiative from the Department of Economics, Rethinking Economics York University, and Innovative Landfill Solutions (ILS) — is working to change that.

We've installed smart cup-sorting stations that collect used coffee cups separately, so they can be properly cleaned and recycled by ILS. Our research explores what motivates sustainable behavior and how factors like education, incentives, and convenience influence students' recycling decisions.
