

Sir Muhammad Zafrulla Khan (1893–1985) was a renowned diplomat, jurist, and scholar. He served as Pakistan's first Foreign Minister, President of the UN General Assembly, and President of the International Court of Justice. A prominent figure in international law and diplomacy, he upheld justice, governance, and public service throughout his career. As a member of the Ahmadiyya Muslim Community, he championed values of service, knowledge, and human rights. He also translated the Holy Quran into English and authored a seminal work on Islam and human rights.



Gunn Prize for Immigration History



In their effort to preserve the legacy of Canada's immigration history and to support continued excellence of research in Canada on migration. Along with the settlement in Canada, the Canadian Immigration Historical Society (CIHS), in cooperation with the Locally Engaged Refugee Research Network (LERRN) and the Department of History at Carleton University, jointly offering the Gunn Prize. A \$1,000 prize for a fourth-year undergraduate or graduate-level research paper on the historical evolution of Canadian immigration policy or a historical analysis of Canadian immigration related to specific places, events, or communities. The prize is named after Al Gunn, one of the founding members of the CIHS and its longstanding Secretary until his death in 2009.
