## InfoPath Information

- The InfoPath file is in XML code and requires Microsoft **InfoPath 2013** to open the document.
- Microsoft InfoPath 2013 software is free with Office 365 ProPlus subscription. Installation instruction in from page 3 to page 6.
- The IR Plan InfoPath forms for 2022/23 reporting year is distributed to the planners along with this presentation on July 27, 2022.
- The filename has an extension of “.xml” and the convention of naming the IR Plan InfoPath file is

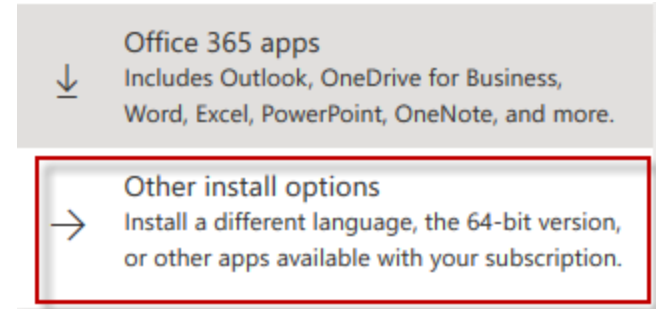

- The Framework section consists of the following fields:
  1. **MISSION** - field content is York's Mission.
  2. **VISION** - field content is York's Vision.
  3. **PRIORITIES** - field content is a summarized version of the UAP 2020-25 six priorities.
  4. **OUTCOMES** - field content includes longer-term outcomes and identifies the SMA metrics.
  5. **PLANNING CONTEXT** - field content includes institutional planning context from the UAP 2020-2025.
  6. **PROMISE** - field content includes the York Brand Promise and is anchored by the UAP priorities – **NEW\***

In addition to the six foundational Priorities above, the plan responds with a challenge to elevate York's contributions to the **United Nations Sustainable Development Goals (SDGs)**, which offer a framework for UN member countries to take urgent action in 17 areas that are critical to ensure peace and prosperity for people and the planet. York University's new UAP serves as a rallying call for students, faculty and staff – a call to bring their expertise from across disciplines to work together to build new tools, develop strategies and solutions to global challenges.

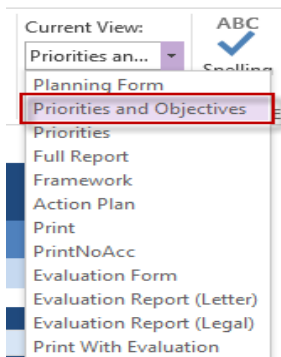
### ➤ 7. Answering the Call

- Planning Form: retrieve plan data and save to database.
- Priorities and Objectives: Priority, Priority Details and Objectives in landscape layout
- Priorities: Priority and Priority Details in landscape layout
- Full report: Includes all the plan contents in landscape layout
- Framework: Includes Vision, Mandate, Core Function Areas, Guiding Principles, Planning Context, KPI in landscape layout
- Action Plan: Includes Priority, Priority Details, Objective, Action, Measurable, Accountability in landscape layout
- Print: Includes all the plan contents; has **auto numbering**, **portrait** layout; eliminate table format of action plan portion.
- PrintNoAcc: Exclude Accountability section from the Print view, portrait layout.

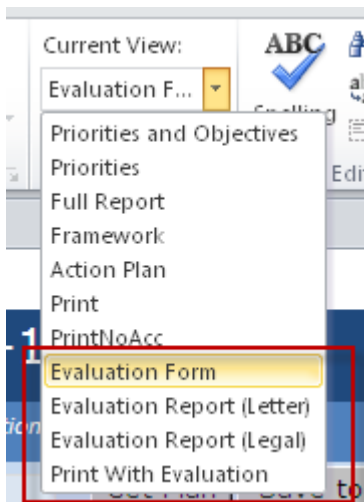

As part of the evaluation of your IR Plan, you will need to assess the status of each measurable action by indicating whether the action item is: not on track; progressing but behind schedule or taking different shape than originally envisaged; on track or on time relative to expectations; or completed during the planning cycle. Examples of the evaluation categories include:

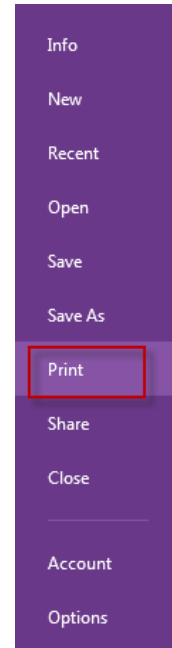

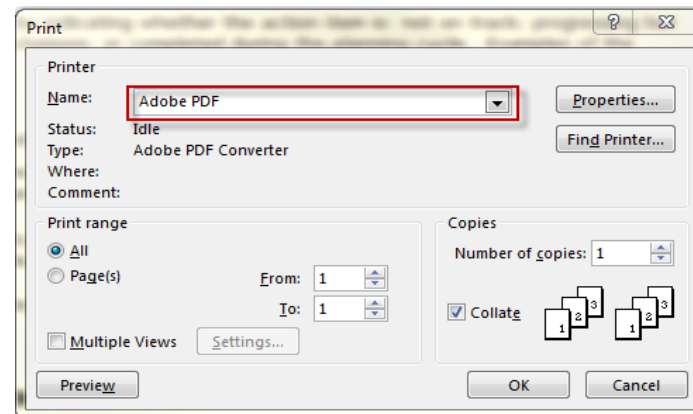

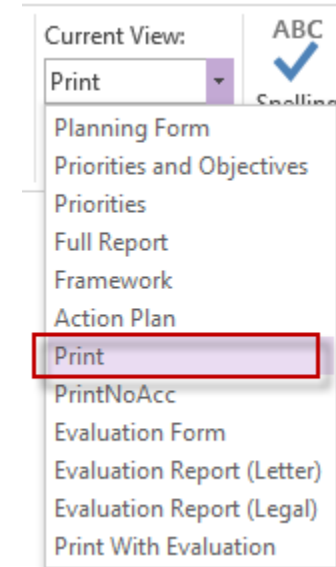




## Print (cont.)

### ➤ Output to Word Document

- Select “Adobe PDF” as the name of the Printer, click OK, then the IR Plan PDF file will be generated.
- Open the PDF,
  - “File” menu > “Export To” > “Microsoft Word” > “Word Document”



### **Note:**

- *Print view has auto numbering feature that the priorities, objectives and actions will be numbered according to its sequence in the action plan. Planners will need to save and then get the plan to/from the database for the auto numbering to take effect.*
- *Planners can print the plan into PDF document for filing purpose. If planner needs to coordinate inputs from multiple people, word document can be generated using the above method to collect inputs and consolidate changes, however the updated contents can't be fed into InfoPath automatically.*

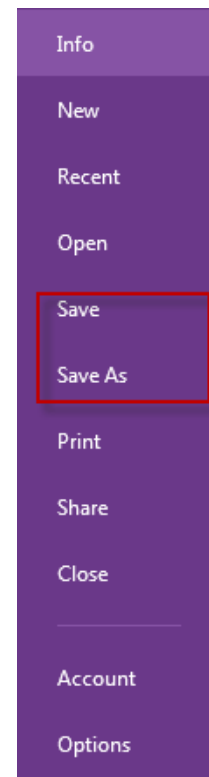


