Laboratory Supplies and Equipment Vendors

This bulletin is to advise the community of a change to the current laboratory supplies and equipment list and to ensure everyone affected takes the actions required in support of the new Laboratory Supplies and Equipment Vendor of Record ("**VOR**") program.

Rationale

To streamline administrative processes associated with procurement of laboratory supplies and equipment, Public Sector institutions are being encouraged to participate in collaborative agreements to consolidate spending and benefit from economies of scale. In support of these priorities, York participated in the Request for Proposal ("**RFP**") for Laboratory Supplies and Equipment posted by McMaster University along with other colleges and universities.
