Biography

Janet Friskney is an editor, and a scholarly researcher and writer. While working in preaward research administration at two Ontario universities since 2007, she honed her skills as a developmental editor of grant and nomination files in the humanities and social sciences. A notable number of faculty members with whom she has worked on applications to the Social Sciences and Humanities Research Council of Canada have received high rankings from their adjudication committees.

Earlier in her career, Janet Friskney served as associate editor to the award-winning third volume of the *History of the Book in Canada* (2007), a 600-page scholarly reference work involving more than 100 authors. As a scholar, she specializes in Canadian book history. She began publishing while still in graduate school, and is most well-known for her monograph *New Canadian Library: The Ross-McClelland Years 1952-1978* (2007). In addition to her three degrees, which include a Ph.D. in Canadian history, Janet Friskney holds certificates in book and magazine publishing, and access to information and protection of privacy.

Editorial Services

• Developmental Editing: Funding Applications / Prestigious Awards

Janet Friskney works collaboratively with researchers who are pursuing funding applications or developing files for prestigious awards. She can:

- Consult with researchers over funding opportunities or prestigious awards to assess how well they align with the project being proposed, or the career profile of the researcher being nominated.
- Provide strategic advice and/or editorial feedback on materials drafted by researchers, with an eye to heightening the competitiveness of the grant or nomination file through thoughtful restructuring and modifications of content.
- \circ Offer suggestions on the elements that will comprise the budget.
- Assess file components for technical compliance with agency guidelines.
- Intervene in texts at the level of the sentence or the word to smooth out infelicities of style.
- Contact program officers at sponsoring agencies for clarifications if the client prefers to maintain anonymity during the file development process.
- Coordinate the collection of letters of support for those files that require them. If a referee is open to feedback on a draft letter, that can be provided as well.
